We do not hold in the scope for this request. If HMCPSI receives a request to carry out an inspection of a body other than the CPS or SFO, the merits and costs of the inspection are reviewed on a case by case basis.

Question 5 . *Any other policy, guidance or manual you hold regarding inspection of non-CPS/SFO bodies.*

We do not hold information in scope of this request. HMCPSI would use the same methodology as used when conducting an inspection of the CPS or SFO amended or adapted to meet the needs of the particular inspection.

I can perhaps assist with some background information. While we do not hold a list of bodies other than CPS or SFO that have been inspected, our Annual Report lists all inspection carried out in the previous year. We have inspected the Service Prosecution Authority at the request of the Director SPA. We have also assisted Criminal Justice Inspection Northern Ireland in its inspection of the Public Prosecution Service of Northern Ireland. In that case, although we loan inspectors, those inspectors are delegated powers by the Chief Inspector Northern Ireland, the inspection is by that Inspectorate, not HMCPSI, and they publish the resulting report on their website.
