

Response to the consultation on HM Inspectorate of Probation's inspection framework and programmes for 2020-2022

October 2020

1. Introduction

- 1.1. Under the *Police and Criminal Justice Act 2006*, Her Majesty's Inspectorate of Probation is required to consult named key stakeholders other inspectorates and ministers each year on its inspection framework and programmes of inspection. It is our practice to consult more widely, with those we inspect and associated bodies who can provide valuable insight and information as we develop our framework and programmes. This year we also extended our consultation to cover not just 2020-2021 but also 2021-2022.
- 1.2. The 2020-2022 consultation letter was issued on 23 March 2020, setting a deadline for responses of 29 May 2020. The consultation letter was published online and is available at: http://www.justiceinspectorates.gov.uk/hmiprobation/about-hmi-probation/consultations/
- 1.3. The consultation set out the following two requests:

2. We welcome views on our proposed research projects for 2020 and beyond.

This document summarises the responses received to the consultation requests and sets out the decisions made by the Inspectorate in response.

1.4 In addition, we conducted a separate consultation exercise on our future inspection approach to the new unified probation service which ran shortly after this statutory consultation. The findings of that consultation are detailed in a separate document but any relevant feedback from this statutory consultation exercise was provided to the Programme Team for their consideration.

In addition, we have identified a long list of thematics for 2021-22 that we will consider as part of our business planning.

Adult

- management supervision
- electronic monitoring, including GPS tagging
- women
- domestic abuse
- MAPPA
- TACT.

The last two topics would need to be conducted jointly and so will require agreement by the joint Criminal Justice Chief Inspectors' Group.

Youth

- management supervision
- Education, Training and Employment
- county lines
- remands
- cases caretaken between YOTs
- youth courts
- Looked After Children & YOT link to social services.

Again, the last project would need to be conducted jointly and so would rely on the agreement of the relevant partner inspectorate.

Our thematic choices will be particularly driven by:

- the systemic issues we have identified in our core inspections
- issues that are flagged in the wider context that have a bearing on probation and youth justice
- ministerial interests.

2 Research

We welcome views on our proposed research projects.

2020-2021

We are undertaking secondary analysis of existing inspection data to develop the evidence base underpinning our inspection standards, at both the organisational level and individual case level. Key topics are as follows:

- the quality of pre-sentence information and advice provided to courts
- probation delivery: links between inputs, activities, outputs and outcomes

- tailoring delivery to children's needs and strengths (youth)
- arrangements with statutory partners, providers and other agencies (youth)
- delivery of out of court disposals (youth).

We will compare findings for different sub-groups (for example by age, gender, ethnicity) where possible.

We are undertaking new primary research in the following areas:

- the research and evaluation activities of probation providers
- caseloads and workloads in probation services
- knife crime and young people exploring promising strategy, interventions and casework
- staff experiences of supervising service users at risk of self-harm and/or suicide
- working with trauma: An exploration of current probation service approaches.

2021-2022

Topics for consideration for 2021-2022 and beyond:

Adults

- knife crime
- enabling environments
- domestic abuse & electronic monitoring/ GPS
- potential to focus on young adults as a subset
- alcohol testing
- sentencer confidence.

We would want to see the conclusions of any ongoing intervention or research activity conducted by the department on the last two topics before we consider pursuing ourselves.

Youth

- youth delivery: links between inputs, activities, outputs and outcomes
- county lines
- YOTs and use of technology
- youth courts
- YOT models
- trauma-informed approaches.

We will continue to use the risk/impact matrix to prioritise our research activity.

2. We welcome views on our proposed research projects.

There was support for the research topics proposed for 2020-2021, especially suicide and self-harm, and trauma-informed practice for adults, though there was a request for us to look specifically at how the co-existence of trauma and brain injury and learning disabilities is managed among those aged 18-24 years.


3.2 A wide range of potential research projects were suggested in addition, as outlined below.


4. Stakeholder feedback

- 4.1 To complement the statutory consultation, we gathered feedback from stakeholders over the summer of 2020 on their perception of the Inspectorate on five key aspects of our operation.
- 4.2 The following figures are based on the responses of 146 stakeholders, 81 per cent of whom were from YOTs (51 per cent), National Probation Service (21 per cent) or Community Rehabilitation Companies (9 per cent).


HM Inspectorate of Probation is independent and speaks independently




HM Inspectorate of Probation reports lead to improvements in probation practice




HM Inspectorate of Probation reports lead to improvements in youth offending practice
