Freedom of Information Act (FOIA) Request – 201223004

Thank you for your request of 23 December in which you asked for the following information from the Ministry of Justice (MoJ):

To provide national CRC, national NPS and aggregated national figures for each of the areas below. Baseline (pre-Covid) figures also to be provided for all possible data where available.

Unpaid Work

Levels of delivery reported for each week between 3 May 2020 and 22 November 2020; Caseload and backlog for each week between 3 May 2020 and 29 November 2020.

Accredited Programmes

Levels of delivery reported for each week between 3 May 2020 and 22 November 2020; Caseload and backlog for each week between 3 May 2020 and 29 November 2020.

Breaches and recalls

Levels of delivery for retained persons each week between 8 March 2020 and 22 November 2020; Levels of delivery for allocated persons each week between 8 March 2020 and 22 November 2020; Breach caseload and backlog for each week between 12 April 2020 and 29 November 2020; Levels of delivery for recalls for each week between 8 March 2020 and 22 November 2020.

Contact

Total contact in the last 4 weeks as at 29 November 2020 and contact ratios for primary offender management contacts for each week between 29 March 2020 and 29 November 2020; Contact frequency in the last month as at 29 November 2020; % of no contact in the last months as at 29 November 2020, and a rolling time-series of % of offender with no contact in the month for each two-week period between 29 March 2020 and 29 November 2020.

It would also be helpful to know, for contextual purposes, when the next round of OM statistics (for September) will be in the public domain. From this, we will extract, for inclusion in the report, information relating to community order and suspended sentence starts; prison releases; unpaid work and accredited programmes imposed; and RAR imposed.

Your request has been handled under the FOIA.

I can confirm that the MoJ holds the information that you have requested and I have provided it in the attached tables. I can also confirm that the next Offender Management statistics are due to be published on 28 January.
